5.	To discuss any Matters Arising

6.	To receive the Borough Councillor's Report	
	No report had been received from the Borough Councillor.	
7.	To Co-opt a new Councillor to fill a vacancy and consider further Co-option at the next meeting.	
	Cllr Harbottle proposed that Lucie Edmed be co-opted to the Parish Council, Cllr Spokes seconded this, and all were in favour.	
	Resolved: That Lucie Edmed be co-opted to the Parish Council.	
	Cllr Edmed completed the Declaration of Pecuniary Interests form and the Declaration of Office form.	
	Cllr Edmed was formally welcomed on to the Parish Council.

8.	To agree the purchase and placement of a new Noticeboard	
	Following discussions at the last meeting, the Clerk had approached Smeeth Parish Council who were happy to contribute up to £500 for a new noticeboard. The Clerk had obtained quotes for a new noticeboard, including one for £751.14. It was agreed that the Parish Council would proceed with the quote for £751.14 for a new noticeboard. It would likely be cemented into the ground with paving slabs placed underneath it for a standing area. It was agreed that The Warren would be a suitable location, but that further discussion with regards to its precise location on The Warren was required.	
9.	To agree a Young Persons Award and steps to take this forward	
	This initiative was discussed and it was agreed that a certificate and voucher (or similar) would be awarded each year in May, starting in 2023, together with the Citizenship	

Award. It was agreed that the Clerk would discuss the initiative with Smeeth Parish Council to see if they too would like to be involved.

The wording for the criteria of the Young Persons Award would be finalised and approved in due course.

10. To review the allowances available to the Clerk

The current allowance being paid is less than this and it was agreed that the Parish Council would increase the working from home allowance paid to the Clerk to £18 per month, effective from April 2022. This would be reviewed annually at the May meeting.

KCC Highways will look into better signage that could be provided for Brabourne School, village gateways and also AONB signage, although the AONB Unit have asked that the latter be postponed because the Government has a consultation in progress on the renaming/regrading of AONBs.
