There was a discussion regarding hire costs for the Village Hall.

9. To agree the setting up of a Community Events Group

Smeeth Parish Council have expressed an interest in being part of this initiative, for which the Parish Council is grateful. The relevant community organisations have all been contacted and several have expressed an interest in being involved.

10. To receive an update on the newsletter

Cllr Smith explained that both she and Cllr Pereboom (Smeeth Parish Council) had met with a lady called Abbie who might be able to assist with the production of a newsletter. There would be initial set up costs and Abbie would charge approximately £500 per newsletter.

The Chairman stated that it was pleasing that the situation was moving forward, but explained that there are several issues that would need to be considered. For example, the Parish Council will need to decide what forms of communication it considers to be necessary for the purposes of communicating with Parishioners. Other matters to be considered would include GDPR-related issues, advertisement-related issues, the amount of time that would be required of the Clerk, etc.

It was felt that no decision could be made at this point. The Parish Council agreed to continue discussions with Smeeth Parish Council.

11. To receive and discuss the communication regarding Trees on The Warren

A recent communication regarding trees on The Warren had been circulated. The Parish Council has already resolved for works to be carried out to the trees on The Warren and these works exceed the recommendations contained within the latest arboricultural survey report compiled in November 2022. These works have already begun.

Resolved: That the Parish Council satisfies itself that it is meeting its legal obligations in respect of all trees on The Warren.

12. To receive communications received by the Clerk

All relevant communications had been circulated.

12.1 Request for a bus shelter

Following discussion, it was agreed that the costs would significantly outweigh the need and that there would be no suitable location in the immediate vicinity of the requested site due to the pavement being too narrow.

12.2 Email from Beavers and Scouts regarding community projects

This is to be taken forward via the Community Events Group, the Community Led Plan and the Playing Field Association.

13. To discuss the Citizenship Award

It was agreed that a Newsflash would be sent out, that a poster would be put on the noticeboard, and a post made on social media.

14. To discuss the Young Persons' Award

The working group is meeting on 2 February 2023 to progress the matter.

15. To receive an update on the Community Led Plan (CLP)

Cllr Edmed reported that the CLP are applying for a grant for wilding the areas just inside the Playing Field car park. The CLP have extended an offer to work with the PFA but have not received a response. The memorial bench is to be installed in the future when the ground is drier. There will be a coffee morning on 25 February 2023 at the Baptist Church looking for ideas, fundraising and recruitment of volunteers.

16. To receive an update on the Village Hall

Cllr Smith reported that a defibrillator has been purchased and installed by the main entrance. The issues currently facing the Village Hall include the heating being powered by a router that needs attention, pipes have frozen in the cold weather, and storage and access remain ongoing issues.
