	The Chairman welcomed everyone to the meeting.	
1.	To receive any Apologies for absence	
	There were no apologies received.	
2.	To receive declarations of interest (Disclosable Pecuniary Interests and Other Significant Interests). The nature as well as the existence of any such interest must be declared.	
	Cllr Atkins declared an interest in planning application PA/2023/1181 due to the proximity of his home to the application site.	
	Cllr Spokes declared a personal interest in the payment of the Litter Picker.	
3.	To approve the Minutes of the meeting held on 22 nd May 2023	
	Resolved: that the Minutes of the Meeting of the Parish Council held on 22 nd May 2023 be approved and confirmed as a true record.	
	The minutes were duly signed.	
4.	To discuss any Matters Arising	
	Stour Downs Foodbank: The application by the Parish Council for £1000 to the Helping Hands grant fund for the Stour Downs Foodbank was successful and the monies have been received. Provision of the funding was discussed.	
	Resolved: that £1000 be given to the Stour Downs Foodbank via Rev. Chris Carnaby-Denyer (Vicar), with delegated authority to the Clerk to determine the nature of the payment; that this funding supersedes all previously agreed funding for the Foodbank.	
	Book Swap: It was reported that a resident who uses the book swap had communicated with Cllr Smith to say that they were unhappy with the state of the phone box book swap, with books that were not novels having been left in a heap. A discussion was had regarding what could be done.	
	Resolved: that the Parish Council communicates with residents regarding the existence of the book swap and how it is intended to be used.	
5.	To receive the Borough Councillor's report	
	A copy of the Borough Councillor's report had been circulated to Councillors.	
	The Borough Councillor added that the leaders of several Borough and District Councils have written a joint letter to the Prime Minister regarding the Stodmarsh Nutrient Neutrality issue.	
6.	Planning Report	
	a) To receive the report of the Planning Committee A copy of the Planning Committee Report had been circulated to Councillors, and a copy is available in Appendix 1 of these minutes.	

b) To receive any outstanding applications and agree a response. PA/2023/1181: Land adjacent to Hillview, Manor Pound Lane

Cllr Atkins did not take part in the discussion nor vote on this item due to his previously declared interest.

The Chairman explained that the site lies outside the village envelope but would likely still be considered as being on the edge of the Brabourne Lees/Smeeth settlement under the Local Development Plan. Cllr Spokes reported that the previous application on this site had been supported, it is within and does not extend the Bircholt Forstal built environ and is not detrimental to the local aesthetic. Cllr Smith raised no objection to the application. It was noted that the proposed dwelling would sit between other housing, although it was further noted that the plot appears to be smaller than the surrounding plots. The proposals must not have a detrimental effect on the residential amenity of the neighbouring properties.

Resolved: that the Parish Council makes a general comment on the application.

OTH/2023/1270 - Abbottsfield, Lees Road, Beech tree

The Parish Council discussed this application. Assuming the reduction is suitable to the health of both trees, the Parish Council raises no objection.

Resolved: that the Parish Council makes a general comment on the application.

b) To note the Financial Position of the Parish Council for the beginning of the new Financial Year up to 30 June 2023.

There is currently £46,290.31 in the bank.

The Clerk was asked to ensure that the savings account interest is benefitting the Council as best as possible.

8. The Warren

a) To consider and agree action over the Open Space Management Plan for The Warren

Initial thoughts regarding the Open Space Management Plan for the Warren had been shared previously by Cllr Atkins. The Parish Council needs to decide what the Plan should contain and to consult relevant stakeholders. There was a discussion regarding the Warren, including views that it should evolve organically, to consider no new benches or trees and only replace what is currently there, that ownership issues of furniture and other items already present may need addressing. The Warren is a community resource and the recent Community Event was very successful.

Resolved: to prepare an Open Space Management Plan and consult relevant stakeholders including residents, the Village Caretaker and Smeeth Parish Council.

b) Warren damage

The damage caused by people parking on the warren and driving on the edge of the Warren is going to take time to resolve.

Resolved: that delegated authority be given to the Clerk to spend up to £5000 on repairing the damage to The Warren.

c) To decide next actions re: the bench on The Warren

The memorial bench on the Warren to the right of the Outdoor gym has been irreparably damaged. After some discussion, it was agreed to purchase a Glasdon Stanford Bench that would act as a more robust replacement.

Resolved: that the Parish Council purchases a Glasdon Stanford Bench for £1333.80 as a replacement bench.

9. Allocation of s.106 monies from development at Clovelly, Canterbury Road.

The Parish Council has been made aware quite suddenly that there are some s.106 monies available. There is a tight time scale for the spending of this money. The Parish Council agreed to allocate the monies as follows:

- Natural Green Space funding for the provision of or improvements to informal/natural green space and associated facilities and maintenance thereof: £759.

There was a discussion regarding whether this money could be spent on a bench for the allotments, as opposed to the replacement bench on The Warren. The allotments are currently unavailable to residents unless they are an allotment holder. It was, therefore, decided that this was not appropriate for s.106 funding but funds towards a bench at the allotments could be considered at the next meeting.

Resolved: that the Parish Council allocates the £759 for the replacement bench on The Warren. [This was approved by 4 Councillors whilst 1 Councillor abstained]

- Outdoor sports pitches contribution towards maintenance of outdoor sports pitches and associated facilities: £326

Resolved: that the Parish Council allocates the £326 to the Playing Field Association for upkeep of the sports pitch.

10. To receive an update on the Highways Improvement Plan

The latest drawing of the gateways had been received and the Parish Council requested confirmation as to the 2 arrows on the latest drawing and requested a perspective of the Brabourne side of the sign.

11. To receive an update on the following:

a) Allotments

The allotment members have been busy making compost bins out of pallets.

b) Caretaker Scheme

The review meeting of the scheme concluded that the scheme is working well, the contingency is adequate and there is to be a workload review in 2025/26. The appraisal is to be undertaken on Wednesday.

c) Community Led Plan

The grant application to fund the wilding project was unsuccessful but is due to be resubmitted. Other funds will be sought. Some of the footpaths have been cleared and kissing gates installed. The pond is sludging up and is due to be cleared, although

ownership is unclear and needs to be confirmed. Some road signs are due to be cleaned. Potholes have been reported. A boot fair is to be held but requires planning. Calland woods need tidying. Two CLP members have put up chicken fencing at the school. The next meeting date is yet to be confirmed.

d) KALC

The details of the last meeting had been circulated to Councillors. There had been a question about whether the new administration will be taking forward the removal of streetlights. ACRK is due to begin working. There was update from Kent Police. Defibrillators need to be registered on The Circuit.

e) Playing Field Association

A consultation is being run on behalf of the PFA regarding what play equipment is desired.

f) Village Hall

The Hall is quiet at the moment.

g) Other Village organisations that are present and wish to provide an update
Nothing to report. Suggestion that Speed Watch report be circulated to Brabourne PC.

12. Communications

It was confirmed that the streetlights consultation response had been submitted.

The Chairman advised that Parish Council communications, and associated matters such as data protection, are all issues that the Council needs to express a formal opinion on. The Chairman suggested setting up a working group to discuss these matters jointly with Smeeth Parish Council. Following a discussion, Cllrs Atkins and Harbottle agreed that they would be willing to be part of a working group.

13. Parish Council vacancies

There are currently 2 vacancies and 2 people have expressed an interest. Pat Thornby and Charlotte Kershaw introduced themselves. The Parish Council will look to co-opt at the next meeting.

14. Open Session

The Borough Councillor explained that Aspire, the Borough Council landscaping contractors, had advised that a tree outside 15 The Warren needs to be removed because the roots are damaging the path and verge. Ashford Borough Council will replace the tree with 2 trees if an appropriate alternate location can be found.

15. Any Other Business

There was no other business.
